ELIGIBILITY FOR MEMBERSHIP

Every Subscriber to the Memorandum of the Society, every Member of the Governing Body and every person who believes in the aims and objectives of this Society and whom the Governing Body may admit as a Member shall be Members of the Society. To become a Member of the Society of Biotechnology Promoters of India (SBPI), the applicants shall apply for membership in this prescribed FORMAT. Eligibility criteria for Membership to SBPI in different categories are as indicated below:

A. INDIVIDUAL MEMBERS

1. Persons holding degree or diploma in biotechnology/life sciences/chemical engineering/biochemical engineering/chemical technology/medicine are eligible for becoming Members
2. Individuals with post –graduate degree in other branches of science or graduate degree in other branches of engineering with a sustained interest in biotechnology/life sciences/biochemical engineering/and allied fields having at least five years hands-on experience in a biotechnology laboratory or in a biotechnology industry are also eligible for Membership.
3. Persons with a degree or diploma in any field but practising in the field of biotechnology/biosciences for at least two years can be considered for Membership on a case by case basis.
4. Managing Directors/Chief Executive Officers/Chief Operating Officers/Presidents of companies operating in India, who have interest in promoting biotechnology; can be Members in individual capacities.

TYPES OF INDIVIDUAL MEMBERS

1. ANNUAL MEMBERS: An annual membership fee is to be paid for the membership. The membership period begins from 1st April of any year to and ends on the 31st of March of the following year. Membership fees, for the following year, if not paid within six months will automatically lead to a termination or suspension of the membership.

2. LIFE MEMBERS : Any person eligible for membership as per provisions of Para (2)(a)(i),(ii) and (iii) of the Memorandum of the Association and Rules & Regulations of SBPI (<https://biotechpromoters.org/moa/Member-SBPI-MOA.pdf>) on making a one-time payment of approved fees may become a life-member and will enjoy all the privileges of a member for his/her life time.

3. FOUNDER MEMBER : Persons involved during the formation of the Society will be the founding members of the SBPI and will enjoy membership for his/her life time. A one-time subscription is payable as per an approved fee structure as provided in the Memorandum of the Association and Rules & Regulations of SBPI.

4. FELLOW: Eminent persons in the field of biotechnology or in any related field or a person of significant scientific attainment from any country may be nominated as a Fellow or as an Honorary Fellow, if so approved by the Governing Body and ratified subsequently by the General Body. Members desirous of proposing such members must send details of the person to the General Secretary. An Honorary Fellow may or may not be a Member of SBPI. A Fellow would have to be a Member of the SBPI.

B. CORPORATE MEMBERS:

1. Any institution approved by the Governing Body may be elected as a Corporate Member of the SBPI and subsequently ratified by the General Body. The term "Institution" may be deemed to include any public or private company or firm, a Society, an educational institution registered under any law, a constituted trust, a statutory body, any Society or special funding organization set-up under an act of the Parliament or a State Government, interested in biotechnology. The Corporate Member will be entitled to receive all the

publications of the Society but will not be entitled to vote, cast, propose, second, or hold any office of SBPI. Annual subscription by the Corporate Member of the SBPI is payable as per an approved fee structures embodied in the Memorandum of the Association and Rules & Regulations of SBPI.

2. Any Institution approved by the by the Governing Body and ratified subsequently by the General Body. Members may be elected as a Corporate Donor Member of SBPI. The Corporate Donor Member shall be an approved Corporate Member who gives a donation to the SBPI.

C. STUDENT MEMBER: A Student Member shall be a student who is enrolled / working towards a degree or diploma in biotechnology or life-sciences or biochemical engineering or related fields in an approved curriculum. Annual subscription by the Student Member of the SBPI is payable as per an approved fee structures embodied in the Memorandum of the Association and Rules & Regulations of SBPI.

D MEMBERSHIP FEES: The Governing Body shall decide about the Membership fees from time to time; presently (2019-2021) the **revised** fee structure is as under:

1. **ADMISSION (REGISTRATION FEES):** Non-refundable fees of **Rs 1000/- (Rupees one thousand only)** to be paid by all Membership categories except for the Student Members.
2. **ANNUAL MEMBERSHIP:** **Rs 1000/- (Rupees one thousand only) per annum.**
3. **LIFE MEMBERSHIP:** **Rs 5, 000/- (Rupees five thousand only)** onetime payment or after a 10 years of continuous Annual Membership payment, the person automatically becomes a Life Member.
4. **FOUNDER MEMBER:** **Rs 5000/- (Rupees five thousand only)** onetime payment.
5. **Corporate Member:** **Rs 25,000/- (Rupees twenty five thousand only) per annum** or a **onetime payment of Rs 2.50 lacs (Rupees two and a half lacs) only** and becomes a Corporate Donor Member.
6. **STUDENT MEMBER:** **Rs 500/- (Rupees five hundred only)** per annum
